## **Laila Twigg-Smith Art Scholarship 2017**

*Laila Twigg-Smith (12/12/44 – 3/24/98) was a well-known art collector; patron of artists and museums; art world personality; artist and visionary.*

### **Description**

This scholarship was established by the Laila Twigg-Smith Art Fund (LAF) Advisory Committee of the Hawai'i Community Foundation (HCF) to support Hawai'i-based artists in study that furthers their artistic development and offers them exposure to new ideas, influences and opportunities.

The program provides scholarships for visual artists to attend the 2017 summer programs at either:

- **Anderson Ranch Arts Center**, Snowmass Village, Colorado or
- **Pilchuck Glass School**, Stanwood, Washington

The scholarship—up to a maximum of \$2,250 per individual—is intended to be used for tuition and fees; housing and meals during the program; and travel. A maximum of two (2) scholarships will be awarded for each school in 2017.

### **Eligibility Requirements**

Eligible scholarship applicants must:

- Be a legal resident of the State of Hawai'i.
- Be a practicing artist, graduate or undergraduate art student.
- Be accepted by the school for admission to its visual arts program.

Preference will be given to scholarship applicants with financial need. Individuals may apply for only one scholarship per calendar year. Additional supplementary materials may be required by each school as part of the application process.

### **Process**

- Scholarship seekers must apply directly to either **Anderson Ranch Arts Center** or **Pilchuck Glass School**. **Applications will not be accepted at the Hawai'i Community Foundation**. Scholarship contacts for each school are listed below:
