



1016 1916

Marks the beginning of The Hawaiian Foundation, the predecessor to what is now known as the Hawai'i Community Foundation (HCF), one of the oldest community foundations in the country.

1923

HCF receives its first gift from Rose Makee Tenney to be used for unrestricted purposes including the promotion of education, scientific research, care of the sick, aged or helpless and improving living conditions regardless of race, color or creed.

1928

Designated funds received for the first time. Irene Holloway donates \$10,000 for Lunalilo Home for aged and indigent Native Hawaiians.

1931

Foundation assets total \$50,897.50. The first scholarship of \$1,510.65 awarded to Miss Theodora A. Floyd, a nurse, to attend Teachers' College at Columbia University.

1936

The Lillian K. Wilder Fund established, the first gift to help needy people in Hawai'i with preference to people of Hawaiian ancestry.

1943

The Honolulu Star-Bulletin starts the Wallace Rider Farrington Memorial Scholarship to help Farrington High graduates attend the University of Hawai'i.

Inspiring the **Spirit of giving** for 95 years

1966

Alice B. Soper leaves \$129,000 in property to the Foundation to be used for the "aged who are sickly, infirm, or helpless and without adequate funds of their own."

1971

HCF attorneys file for recognition by the IRS in compliance with the 1969 Tax Reform Act as a community trust and not a private foundation.

1977

Ruling by the IRS confirms that the Foundation is a publicly supported organization.

1987

Reorganization of the Foundation to corporate form with multiple trustees and a Board of Governors. The Hawaiian Foundation renamed Hawai'i Community Foundation.

Robert E. Black dies and bequeaths the largest discretionary endowment in Hawai'i's history with more than \$60 million to the Foundation. His desire is for the income from the fund to support four areas of charity-health, residential treatment, culture and private education.

1988

The Board of Governors elects James F. Gary as its first President and appoints Jane Renfro Smith Chief Executive Officer. First Donor Advised Fund, the Sheridan C.F. Ing Fund, established on January 11.

1989

Hawaiian Trust Company, Ltd. (Bank of Hawai'i), the sole trustee of the Foundation for 72 years, is joined by Bishop Trust Company as a corporate trustee. HCF begins developing grantmaking programs reflecting donor interests and community opportunities. Over \$900,000 is committed to a three-year demonstration project in Early Education and Care.

1991

First Hawaiian Bank becomes a corporate trustee.

1992

HCF grows to \$166 million at the end of 1992 from \$12 million in assets in 1988.

The Parker Ranch Foundation Trust established under the Will and Trust of Richard Smart and with the mission of maintaining and improving a unique quality of life in Kamuela, Hawai'i.



1003

From 1993-1995, HCF awards grants averaging in excess of \$9 million per year. Fund accounts at HCF grow to 100.

1995

HCF assets grow to more than \$216 million and awards 1,326 scholarships worth more than \$1.4 million to Hawai'i students.

First public-private partnership established with the Hawai'i Children's Trust Fund with the mission of preventing child neglect and child abuse. The Department of Health serves as the lead agency for the public sector and HCF provides oversight of the endowment.

1998

Kelvin H. Taketa named President and Chief Executive Officer.

Strategic focus on developing grantmaking programs to support nonprofit agencies and serving as an information resource on the nonprofit industry, community issues and trends.

1999

HCF commissions "The Hawai'i Giving Study," the first of five studies initiated to examine the issues affecting the nonprofit sector, philanthropy and civic leadership.

HCF partners with two Californiabased private foundations, The William and Flora Hewlett Foundation and The David Lucile Packard Foundation, on The National Resources Conservation Program, a grantmaking program to help secure the long-term health of Hawai'i's natural resources. HCF named as administrator of the Hawai'i Tobacco Prevention and Control Trust Fund. Hawai'i legislature creates this special trust fund from a portion of the multi-million dollar settlement from a lawsuit brought against the tobacco industry.

Increased focus on strengthening the organizational capacity of nonprofits, and faith- and community-based groups, as well as supporting the development of civic leaders.

Central Pacific Bank becomes a corporate trustee.

2000

HCF's efforts to become a statewide, charitable services and grantmaking institution begin with the opening of a full-service office in Waimea on Hawai'i Island.

Focus of HCF's donor services program shifts to emphasize providing charitable services to individuals, helping them structure their gifts to maximize their giving and its enduring social impact, regardless of whether or not the funds reside at the Foundation.

HCF administers \$20 million in grants and charitable assets grow to \$284 million with 33 new funds.

2000

HCF opens full-service offices in Wailuku, Maui-serving Maui County-and Līhu'e, Kaua'i, bringing HCF's services statewide.

"Hawai'i Nonprofits 2001" surveys nonprofit organizations in Hawai'i to identify how they use public and private funds, and the characteristics and issues that are common to the nonprofit sector.

September 11th Fund is established giving Hawai'i residents the opportunity to respond to the needs of the victims and their families of the terrorist attacks at the World Trade Center and the Pentagon. A total of 6,400 gifts were made totaling more than \$900,000.

HCF commissions "People and the Sea 2001," a review of expert opinion of what it will take to enhance the conservation of marine resources in the main Hawaiian Islands.

Employees of the Hawai'i Community Foundation voluntarily establish their "Walk the Talk" charitable fund as a means for them to channel their personal passion for helping others and their community.

HCF participates in a national study, "Daring to Lead 2001," on nonprofit executive directors to look at their characteristics, professional background, recruitment, compensation, job satisfaction and retention, and kinds of executive training and support they receive.

2002

HCF becomes one of the first community foundations in the nation to make scholarship applications available online. Number of applications increase from 300 to 1,000 in the first year, and to more than 6,000 in 2006.

Fund accounts at HCF grow to 300.

"Hawai'i Giving Study 2002" conducted as a follow-up to the 1999 study to examine charitable giving patterns among Hawai'i residents and how it may have changed since the first study.

2003

\$3,974,000 allocated to HCF through the Department of Justice-Office of Community Oriented Policing to carry out enforcement, treatment and prevention/education activities to combat use of crystal methamphetamine in Hawai'i.

Launch of public-private partnership, the "Crystal Methamphetamine (ICE) Initiative," working closely with the county governments, nonprofits agencies and community groups to develop a comprehensive approach involving enforcement, prevention and treatment around ICE use in Hawai'i.

Inspiring the Spirit of giving for 95 years

2004

Nearly \$1 million in grants and contracts made to build the nonprofit sector, providing technical assistance and supporting capacity building projects among nonprofits and community organizations.

Crystal Meth Initiative grant of \$1 million over two years committed to fund the first and only residential substance abuse treatment program for youth on Hawai'i Island, run by Marimed. With this initial funding to start program, two years later in 2006, Marimed is able to secure a \$14+ million grant over six years from the state.

2005

Highest number of funds (52) established in one year with donor advised funds and scholarships leading the way.

Steward of 440+ funds established by generous individuals, families and businesses.

HCF administers nearly \$30 million in grants. \$20 million in grants from HCF funds and \$10 million from 18 private foundations for which HCF provides contracted administrative and grantmaking services.

2006

HCF and First Hawaiian Bank announce formation of the Jack and Marie Lord perpetual charitable fund with assets in excess of \$40 million.

HCF establishes funds to help families affected by two catastrophic events: the Kaloko Reservoir dam breach on Kaua'i, and the 6.7 magnitude earthquake on the west side of Hawai'i Island.

"Hawai'i Nonprofits 2006: One Fabric, Different Threads," HCF's second nonprofit study, highlights the diversity and importance of the sector.

2007

HCF partners with the W. K. Kellogg Foundation to create Youth Matters, an initiative focused on building a network of frontline organizations to help at-risk children.

2008

Schools of the Future Initiative launches to support 18 private schools in their quest to define what success looks like for 21st Century students and classrooms.

Arts in Schools program is formed in partnership with the State Foundation of Culture & the Arts to double the number of artists and art instruction in public schools.

2009

The Hawai'i Community Stabilization Initiative, a collaborative of 11 funders, is introduced to stabilize communities and help local families weather the economic crisis.

Pierre and Pam Omidyar make the largest single gift by living donors in the state with a six-year, \$50 million commitment to HCF to support its philanthropic interests in Hawai'i.

HCF revisits local household philanthropic patterns and trends in its updated study, "Hawai'i Giving 2009."

In response to a challenging economy, HCF distributes \$41 million in grants and contracts to the community the highest amount in the history of the Foundation.

2010

The Island Innovation Fund is created, encouraging a culture of innovation and fresh ideas from the nonprofit sector to bring meaningful change.

HCF's environmental program expands and partners with local and national funders, including the National Oceanic and Atmospheric Administration, around marine conservation. As part of HCF's Building the Sector Initiative, the Hawai'i Emerging Leaders Program cultivates up-andcoming nonprofit leaders.

HCF forms Hawai'i Youth Opportunities Initiative, a collaborative of funders that provides support to young people transitioning from the foster care system to the "real world."

1,400⁺ scholarship awards totaling over \$4 million are granted, making HCF the second largest private administrator of post-secondary scholarships in the state. Number of applicants grows to nearly 8,000.

Assets under management total \$521 million; charitable funds near 600.

2011

HCF moves into the historic C. Brewer Building in downtown Honolulu. The new space serves as a true gathering place for philanthropy now, and for years to come.

Because of our size, we can handle front and back office administrative services at a reasonable cost.

We convene community members and leaders around key issues. We believe that social investments can be highly leveraged by bringing together nonprofit, community and government leaders and funders to plan, share, learn and collaborate. The Foundation often plays this critically important role, as we have recently, to generate solutions for substance abuse, at-risk teens and creating educational innovation for 21st century schools. **programs to achieve broad impact.** We work with nonprofit providers, foundation boards, advisory committees and community leaders to fashion grantmaking programs to meet specific objectives as determined by donors and clients, or the Foundation's Board of Governors Hallmark programs include

Governors. Hallmark programs include our initiative around building the capacity and leadership of the nonprofit sector, serving as the largest public provider of post-secondary education in Hawai'i and our support of family foundations.

We are the recognized resource on nonprofits and philanthropy. The

Foundation is the "go to" place to learn about the work of nonprofit agencies, charitable giving and the context and trends that affect them. We commission surveys and studies to track industry trends, household giving, volunteering and executive tenure. We organize workshops and conferences, and provide commentary to the general public through traditional and new media venues.

In our own words

As you can tell from the various services we provide and the breadth of our work, exactly *what* we do can be difficult to convey in 30 seconds or less—the time span of a typical "elevator speech." It is because we are different things to different people.

In celebration of the Foundation's 95th anniversary, we asked others in the community what the Hawai'i Community Foundation means to them and what their elevator speech for the Foundation would be. This report contains descriptions from some of these voices—an interesting and colorful sampling that not only reaffirms the diverse nature of what we do, but also highlights some of the incredible relationships that we are grateful to have formed.

2010: A year in review

In 2010, the Foundation secured an agreement to relocate its O'ahu offices to the historic C. Brewer Building in downtown Honolulu. In addition to gaining a significant cost savings to our operating budget, this new space gives the Foundation its own unique identity—a true gathering place for philanthropy. Thanks to the generosity of our clients and donors, the Foundation also remained in solid financial shape amidst the recession. Since the demand for nonprofit programs and services is always greater in a down economy, the need for the Foundation's resources was important more than ever before and we were able to invest \$36 million in the community on behalf of our clients and partners.

A significant portion of those funds were focused on several exciting partnerships that were launched or continued in 2010. The Hawai'i Community Stabilization Initiative, a *hui* of 11 funders, made some promising progress in its first year of supporting programs to assist families and individuals in financial crisis.

The Schools of the Future Initiative, a partnership with the Hawai'i Association of Independent Schools to transform 18 private schools in their quest to redefine learning for 21st century students, saw significant instructional changes in many of the schools.

Continuing with the momentum of 21st century learners, the Island Innovation Fund was launched last fall. The fund supports a culture of

innovation and fresh ideas within the nonprofit sector with the goal of bringing about significant change. The idea has garnered attention in the nonprofit sector and has become a fantastic learning experience for the participants and for us as well.

In addition, our environmental program expanded thanks to a new partnership with the National Oceanic and Atmospheric Administration around marine conservation. We also launched the Hawai'i Emerging Leaders Program as part of our efforts to strengthen the nonprofit sector. Read more about these programs and other Foundation priorities on page 25 of this report.

In the area of leadership at the Foundation, we said goodbye to Governors Laurie Ainslie, Claire Asam, Jean Cornuelle, Anthony Guerrero, Jr., Peter Ho and David Nakada. These individuals were incredible leaders and supporters of the Foundation, and we thank them for their service. We were also pleased to welcome new Governors Deborah Berger, Mary G.F. Bitterman, Robert S. Harrison, Bert A. Kobayashi, Jr., Colbert Matsumoto and Kitty Wo.

As we continue our mission, we are reminded of how fortunate we are to live in these islands and more importantly, how privileged we are to be your partner in philanthropy. Total Grants Invested in the Community in 2010



Advancing the Nonprofit Sector, Strengthening the Community

Hawai'i Community Foundation invests charitable funds in communities across the state primarily through nonprofit organizations. Our core programs and initiatives are designed to support a stronger nonprofit sector, as these organizations are one cornerstone of a vibrant civic society.

BUILDING THE SECTOR INITIATIVE

The Foundation is committed to strengthening nonprofits by supporting organizational capacity building, leadership development, and targeted technical assistance.

Organizational Capacity Building

HCF offers four organizational capacity building grant programs, all of which are designed to strengthen some aspect of a nonprofit's management or governance.

Leadership Development

Promoting Outstanding Nonprofit Organizations (PONO) Leadership Program

PONO is a 10-month, peer-centered leadership development program for mid-career nonprofit executives. The goal of PONO is to create a network of empowered, innovative, and resilient executives, capable of navigating change and moving their organizations towards greater social impact.

The 8th class of PONO fellows was launched in August 2011

Hawai'i Emerging Leaders Program (HELP)

HELP brings together senior nonprofit managers for a seven-month learning experience to strengthen their leadership

capacity, advance their understanding of the competencies needed to lead a nonprofit, and create a network of nonprofit colleagues to help sustain them and their organizations. There is no other program in Hawai'i focused on developing the capacity of senior nonprofit managers.

The inaugural class of 15 senior staff from nonprofits statewide was formed in 2010

Targeted Technical Assistance

For the last four years, the Foundation has worked with the Nonprofit Finance Fund, a national nonprofit consulting firm. NFF provides workshops and one-on-one technical assistance to help local nonprofits use financial information to make better strategic decisions, and plan for long-term sustainability.

PARTNERSHIPS & COLLABORATIONS

In recent years, the Hawai'i Community Foundation has partnered with various government agencies and other funders to bring resources to program areas such as health, human services and the environment.

HCF/NOAA Community-based Coastal Restoration Grant Program

Hawai'i Community Foundation and the National Oceanic and Atmospheric Administration Restoration Center (NOAA RC) formed the communitybased Coastal Restoration Grant Program, a funding opportunity for on-the-ground coastal and marine restoration projects led by local community groups and communitybased partnerships.

Specific areas of interest include: restoring and protecting coral reef habitat, coastal wetlands and estuaries; addressing and reducing land-based sources of pollution; reducing aquatic invasive species; and restoring traditional cultural infrastructure that benefits coastal communities' ecosystems.

Hawai'i Children's Trust Fund

The fund was established at the Hawai'i Community Foundation in 1993 as a public-private partnership with the Department of Health. It supports programs aimed at preventing child abuse and neglect through grants for direct services, community events, public awareness and advocacy.

Hawai'i Community Stabilization Initiative (HCSI)

This initiative is a three-year, \$4.6 million commitment by a collaborative of 11 funders who are committed to helping Hawai'i families and individuals weather the recession and build towards the future.

Grants supported staff capacity and outreach at nonprofit organizations that saw escalating demand for services as the economy worsened. Funds were distributed in areas where there was high potential to draw down underutilized federal resources. In many cases, HCSI enabled critical family support services to continue uninterrupted.

Nonprofit organizations that received an HCSI grant were able to accomplish more in less time, including reports of increased traction with their clientele.

Hawai'i Tobacco Prevention and Control Trust Fund

The Hawai'i Legislature created this fund in 1999 from a portion of the money that was awarded to the state as a result of the multi-million dollar settlement against the tobacco industry. Under a contract with the Hawai'i State Department of Health, the Foundation administers this Fund.

Island Innovation Fund

Island Innovation Fund was established as part of the historic \$50 million gift to the Hawai'i Community Foundation by philanthropists and Hawai'i residents Pierre and Pamela Omidyar. It is designed to foster new ways of solving various problems that the state faces through the sharing of great ideas.

The Fund is unique in both focus and process. It utilizes the power of emerging technology, collaborative problem solving and strategies to address changing workforce needs and demands. In the first of three grantmaking rounds, 180 organizations submitted their creative concepts to the Foundation for consideration. The entries were shared with the public on a dedicated website, *InnovationFund.org.* Five nonprofits received a grant in the initial round.

Over the next two years, the Foundation will distribute more than \$2.5 million to support innovation.

Schools of the Future

Schools of the Future is a five-year initiative of the Hawai'i Community Foundation and the Hawai'i Association of Independent Schools. It is designed to support a cohort of independent schools to transform their learning environments and teaching strategies to better prepare students for work and citizenship in the 21st century.

Multi-year grants have been awarded to 18 participating schools.

SIGNATURE SECTOR-BUILDING PROGRAMS & EVENTS

Ho'okele Award

The annual award, established in 2002 in partnership with the Wallace Alexander Gerbode Foundation, recognizes outstanding leaders in Hawai'i's nonprofit sector.

Board Leadership Conference

Since 2004, the Foundation has sponsored a conference that provides vital information to board members of nonprofit organizations. Issues addressed include governance, fiscal sustainability, fiduciary responsibility and innovative ideas for conducting business in the reality of today's economy.

This year the Board Leadership Conference is part of the Conference of Nonprofit Communities of Hawai'i —a two-day mega-conference for leaders, employees and volunteers of the nonprofit sector.

I used to think of the Hawai'i Community Foundation as a place where I went to find answers. It has amazing resources, and I did find answers. But the most valuable thing I've received from the Foundation is questions! HCF staff would hear me out on an issue that I wanted PBS Hawai'i to address. Sometimes, as they called upon their broad background in the nonprofit sector, their probing would take me in different, unexpected

directions. That would send me back to the drawing board with the glimmer of a new approach. Our staff likes a challenge. We'd re-think and re-sculpt. When I returned to the Foundation offices, I had my own answers—and a proposed project that used more layers and refined targeting, to serve the community far better than originally envisioned. That's the way the Foundation works—it marshals new perspectives to do more with what it has.
